 police. Co-ordinators can look after part of a street, a street or several streets. Mr

 messaging service via Essex Police website which will send relevant information with
 regards to where the person lives.

 ECC Cllr Goggin was pleased that Rosie Catford and Mr & the late Mrs Jelly both received Pride of Tendring Awards this year. The central bollards along Brightlingsea Road have been cleaned. He will forward a transcript of ECC leader's budget speech, for information. ECC needs to save £1 million pounds each week for the next 4 years. The ECC council tax is going up by 1.99% and the social care levy by 2%.

Cllr Heaney stated that there will be a 1.99% increase in TDC council tax for 2016 / 2017 year. She has made requests for rubbish clearing along A120 / A133. However they will not litter pick along the central reservations. It was recommended that the parish council complain to TDC about this as well. It was confirmed that the streetlights in the TDC area will not be switched on between midnight and 5am.
