## Minutes of Thorrington Parish Council's Meeting held at the Village Hall on Wednesday, 7th September 2016

- To review the annual play area inspection report 15. It was agreed to obtain a quote to lift the clearance height under the trees to between 2m to 3m.
- Councillor & Clerk's Reports 16. The clerk reported that he had completed the declaration of compliance for automatic enrolment duties with the Pensions Regulator.

The Thorrington Village Day 2016 accounts were reviewed. £500 is being donated for extending the electrical supply to the skateboard area on the playing field. £100 is being donated to TPC for Thorrington in Bloom. The committee requested more flowers be planted. The provisional date for the Village Day next year is the second Saturday in August.

Cllr Miller reported that things were progress with both the Tesco Bag Grant and ECC CIF Grant for a new skateboard. She hopes to have some more news shortly. There are 2 streetlights currently not working. One going along Clacton Road from Thorrington Cross the first light on the right is not working and the second is the light by Heathlands path cut through. The clerk will report these.

Several of the flexible bollards on the central islands going down Brightlingsea Road are bent over. The clerk will report these.

The clerk will chase the various lights not in operation at Thorrington Cross. The clerk will report the dangerous state of the manhole cover along Clacton Road going towards Clacton just past Thorrington Church on the church side of the road.
