Minutes of the Parish Council meeting held in the Village Hall on Wednesday 2nd September 2020 at 7pm

The meeting was called to order at 7.01pm by Cllr P Sadler, Chairman

1. Apologies for absence - None received

3. Minutes of previous meetings

(a) Extraordinary meeting

The minutes of the meeting held on 18th February 2020, having been previously circulated, were agreed by those present and signed by the Chairman as a true and accurate record.

(b) Last meeting

The minutes of the meeting held on 4th March 2020, having been previously circulated, were agreed by those present and signed by the Chairman as a true and accurate record.

5. Reports from District & County Councillors

DCllr Scott reported that he and DCllr Wiggins attended a virtual All Members Briefing on 1st September at Tendring District Council (TDC), discussed was the soon to be published white paper on Local Government Reform and the white paper on Planning for the Future.

DCllr Scott advised he continues to receive regular updates on the coronavirus situation from Ian Davidson, Chief Executive of TDC.

Recycling boxes have been given to residents in Avocet Place.

DCllrs Scott and Wiggins have delivered medicines to residents in Thorrington.

Very positive comments from residents regarding the resurfacing of Thorrington Cross have been received.

Cllr P Sadler mentioned the rotten wooden bollards at HCOS to CCllr Scott and he will ask for a site visit from the Essex Rangers.

The owner of Alresford Venture playground is looking for 14 members of staff, DCllr Scott has requested that local people from Thorrington and Alresford are considered for roles first.

DCIIr Scott was thanked by the Chairman and left the meeting at 7.17pm to attend the Alresford Parish Council meeting

CCllr Goggin bought to Councils attention that planning had been granted for Alresford Venture Park but there are concerns regarding the entrance coming out onto a 60 mph road.

The B1027 speed review is in document stage and the Local Highways Panel (LHP) are meeting on 17th September.

The Colne Community School will be having a zebra crossing installed outside of the school.



CCllr Goggin requested information regarding the pot holes for the pothole initiative 2020.

Each County Councillor has been given £10,000 to spend in their area for the benefit of residents. CCllr Goggin has asked the Council to come up with ideas for possible projects.

Cllr G Parks asked if CCllr Goggin could report a yellow road sign that had been left at Thorrington Cross following the recent roadworks.

CCllr Goggin gave thanks to all the volunteers that helped during the lock down.

Cllr G Parks asked CCllr Goggin for an update regarding the Chapel Lane junction which goes onto the B1027. He was advised that the junction will remain unchanged unless the proposed layout by ECC was accepted.

CCllr Goggin was thanked by the Chairman and left the meeting at 7.52pm to attend the Alresford Parish Council meeting
